## THE DATA PROCESSING "INCUMBENT" AND DATA PROCESSING LOCATION

Data referring to identified or identifiable persons may be processed following consultation of this Site. The "incumbent" of such processing is GAMA MOVIE ANIMATION S.r.l. Via G. ## TYPES OF DATA PROCESSED

IT systems and software procedures used to operate this Site acquire in the course of normal operation certain personal data, transmission of which is implicit in the use of Internet communication protocols. Such information is not collected in order to be associated with the identified parties but may by its very nature make identification of users possible through processing and association with data held by 3rd parties. This category of data includes the IP addresses or domain names of the computers used by users connecting to the Site, addresses in the URIs (Uniform Resource Identifier) of resources requested, time of request, method used to submit the request to the server, size of the file obtained in reply, numeric code indicating the state of the response given by the server (done, error, etc.) and other parameters relating to the user's operating system and IT environment. These data are only used to obtain anonymous statistical information on the use of the Site and to run operational checks and are cancelled immediately after processing. Data could be used to ascertain liability in the case of alleged computer crimes affecting this Site.

## DATA PROVIDED VOLUNTARILY BY USERS

Optional, explicit and voluntary sending of e-mail to the addresses indicated in this Site entails subsequent acquisition of the sender's address, which is needed to reply to requests, and of any other personal data included in the e-mail. Summary information on privacy will be indicated or displayed from time to time in the pages of the Site referring to specific services on request. ## COOKIES

The parties to whom personal data refers are entitled at any time to obtain confirmation of whether or not such data exists and to know the content and origin thereof and to check its exactitude or request addition to or updating or rectification of such data (art. 7, decree law 196/2003). Under the aforementioned provision of the law, parties are entitled to request cancellation, transformation into an anonymous form or blocking of data processed in violation of the law and in any case to oppose, on legitimate grounds, the processing of personal data.
